As the Reopening order indicates, "probate cases will be heard remotely pursuant to Supreme Court Order 2020-39, unless the Judge determines and provides notice that a hearing or matter will be heard in person."

## o 11:00 a.m. Appointment Docket

- \*Original will <u>must be received</u> by the clerk's office no later than 24 hours before the scheduled hearing date.
- Attorneys are advised to pre-sign the fiduciary bond forms before filing.
- o 1:00 p.m. Motion and Notice Docket

Beginning June 29, 2020, Jefferson Probate Court will resume dockets <u>remotely</u> on Monday, Tuesday, Wednesday, and Thursday at the *normal probate* times:

## o 1:00 p.m. Appointment Docket

- \*Original will <u>must be received</u> by the clerk's office no later than 24 hours before the scheduled hearing date.
- Attorneys are advised to pre-sign the fiduciary bond forms before filing.
- o 1:30 p.m. Motion and Notice Docket

Public Administrator cases will be heard on these dockets.

### Other Protocols to Note:

- Rule Docket is postponed until further notice.
- All contested probate hearings will be scheduled at a time designated by the Court. Hearings not heard due to court closure will be rescheduled chronologically by the Court.
- The Jefferson County Clerks office will be sending court notices that include the above remote appearance information (box above). This information should also be used by the attorneys for notice to other parties/heirs/beneficiaries/creditors.
- Parties shall continue to E-file and/or use the Dropbox located outside of the Hall of
  Justice (filing cabinet is located on Sixth Street side entrance to Hall of Justice. Contact
  the probate office at 502-595-4434 when something is dropped, and the clerks will
  immediately come down to retrieve it).
- For will recording fees, you will be billed by the County Clerk at a later time. You should NOT deliver the recording fee to the Circuit Clerk.
